- September meeting minutes
  - Sheila suggests a change that Marie, not George, is on the committee to review dog regulations
  - With this change, the board moves to approve the Sept meeting minutes
- Harbor Master report
  - Sprinkler system has been drained
  - o Car wash port remains operational until further notice
  - o Fire suppression line was purged
  - o Parking lot refinishing and restriping successfully completed
- Treasurer report
  - The new QuikBooks solution will be \$85/mo and not \$22/mo as previously discussed, to ensure we have all the features we need

  - O Dog issue:
    - Committee met and worked to propose bylaw language change
    - Suggestion to separate out the two issues: language needs to change to account for ESA/ADA dogs, everyone please vote "yes" or we are at risk of lawsuit (22 houses must vote "yes" to change bylaws). THEN determine whether people want to change the dog ruling.
    - Survey to be distributed (one per household) prior to next month's meeting to get a sense of what people think
    - Correction to minutes: President Don Larsen noted that in order to change the ByLaws, there needs to be an 86% majority vote. In addition, the current ByLaws prohibit dogs. That prohibition does not conflict with ADA policy and there is no lawsuit concern.

#### Old business

- Security- Paul's car was broken into, we have video footage but it isn't preventing anything. Should we stop paying for video footage, or use it to learn how people are getting in/out, etc.?
